

in the City of Lake Mary, in reference to a theft.

Upon arrival I met with Machelle Dean, who advised she is the owner, along with her ex-husband, David Dean, of the residence at the address mentioned above. Ms. Dean advised that for the last year she had rented her house to George Zimmerman on a menth-to-month basis. Ms. Dean advised that during the initial drafting of the rental contract certain items belonging to her remained at the residence and were listed in the contract as items that would continue to remain as such. Ms. Dean advised she was contacted by Mr. Zimmerman's attorney Mark O'mara, and he informed her that she could take back possession of the residence of 09/26/2013, and that Mr. Zimmerman would have vacated the property by that date. Ms. Dean said that Mr. Zimmerman was instructed, through his attorney, to not remove any items not belonging to him.

Ms. Dean advised that when she arrived at the property today to do a walk-through she noticed several areas in the house that had been damaged, such as the writing on the kitchen cabinets. Ms. Dean also noticed several items missing to include a big flat screen TV valued at approximately \$1800, a high top table set with (4) chairs, and a (3) piece leather theatre seating set valued at approximately \$3000. Ms. Dean also advised she was not sure if Mr. Zimmerman had completely vacated the residence, as there are still belongings of his that remain. She also advised Mr. Zimmerman has returned neither the keys nor the remote to the garage.

Ms. Dean advised she did not give Mr. Zimmerman permission to take the property; in fact, she said she explicitly told Mr. Zimmerman not to take the property. Ms. Dean advised she wishes to prosecute. Ms. Dean provided a sworn statement.

Ms. Dean advised that Mr. Dean would be able to provide a copy of the rental contract the next day. She would also attempt to locate any documentation about the stolen property.
