On Tuesday, September 9, 2014, at approximately 1115 hours, I responded to the Circle K store at 4410 West Lake Mary Blvd., Seminole County, Florida, in reference to a complaint of threats. Upon my arrival, I met with the complainant, Matthew Apperson, who identified himself to me with his Florida drivers license. The complainant stated the following information to me:

At approximately 1100 hours this date, the complainant exited Waymont Court and made a u-turn to travel westbound on Lake Mary Blvd. In front of the complainant, was a gold Honda "Ridgeline" pickup truck with a Kel Tec sticker on the rear. The complainant told me that he went into the right lane and the pick-up truck was also traveling westbound on Lake Mary Blvd., in the center lane. The complainant told me that he saw through his peripheral vision, the gold pick-up truck staying next to him, not accelerating or slowing. The complainant then stated that he had his radio on listening to music, when he came to a traffic light.

Matthew Apperson then told me that he looked over to his left, and the pick-up truck had the window open, and the occupants were yelling at him. The complainant stated that when he lowered his window to ask what was wrong, the driver said, "Why are you pointing your finger at me? I fucking kill you. Do you know who I am?" Matthew Apperson said that he believed the driver to be George Zimmerman, and Matthew drove away to the Circle K store. I asked the complainant why did he drive to the Circle K store, and he said he had originally planned to go there to buy a cup of coffee, and left his cell phone at his job.

Once at the Circle K store, Matthew stated that as he exited his vehicle, the gold Honda pick-up truck drove toward him, and stopped and began yelling at him again. Matthew stated that he went to the clerk at the Circle K store and asked to use the phone to call the Lake Mary Police.

While speaking to the complainant, I observed a bulge in the front of his pants, and a black belt clip protruding from under his shirt. I asked the complainant if he was carrying a firearm and he stated he was. He then produced his valid Florida concealed weapons license. I then had the complainant place his firearm in the trunk of his vehicle for officer safety.

I asked the complainant if he had obtained a tag of the vehicle and he stated he did not. I asked him if he ever observed a firearm and again, he stated he did not. I then entered the Circle K store and spoke to Josh, the clerk working behind the counter. Josh agreed to permit me to view the video from the the surveillance system. The video shows a Honda Ridgeline near the complainant, but the driver had a baseball hat on and his face is not identifiable. As Matthew entered the store, the Honda pick-up truck left the area. There are no other independent witnesses to the incident.

I explained to Matthew that without the tag, witnesses and/or clear video identifying the driver as George Zimmerman, it might be difficult to prove the alleged suspect was in fact, Zimmerman. Matthew stated that he did not wish to prosecute in reference to this incident and signed a refusal to prosecute forml. Due to Matthew refusing to prosecute, attempts to locate Zimmerman or the

On 09/10/14 at approximately 1110 hours, I assisted Ofc. Tomassi with a reported Assault call that had occurred in the area of Lake Mary Blvd and Lake Mary Centre within the city of Lake Mary. The call screen advised the following, "COMPL WAS DRIVING DOWN LMB WHEN HONDA RIDGELINE OCCP BY GEORGE ZIMMERMAN ROLLED DOWN WINDOW AND THREATENED TO SHOOT

COMPL".

The screen further advised that there was a Keltec sticker in the back driver's side window".

The screen further advised that there was no weapon seen by our caller.

Dispatch advised that the suspect vehicle was not on scene any longer and that the caller was inside the Circle K using their land line.

Due to my previous knowledge of Mr. Zimmerman's last known address, I drove to that area of the city in order to BOLO for Mr. Zimmerman and/or the Honda Ridgeline.

My previous encounter with Mr. Zimmerman was some time ago but I distinctly remember his Honda Ridgeline being a darker Greenish color and not gold.

I checked the area of his last known residence for a period of time and then received a call from Ofc. Tomassi in reference to the caller not wanting to proceed with prosecution or an offense report.

Ofc. Tomassi explained that he viewed the surveillance video at the Circle K. Ofc. Tomassi then advised he could see the Gold Honda pull up near the front of the store. He could see the caller and a male that appeared to be of thin build, with a hat on talking to the caller. According to Ofc. Tomassi there did not appear to be any aggressive or threatening body language being made by either party on the video.

After speaking to Ofc. Tomassi and being advised that we had no victim wishing to follow up on the alleged assault, I left the area and resumed normal patrol.

I should be noted that only the caller identified the driver of the Gold Honda as Mr. Zimmerman. We have no independent witness' to the events as described by our caller and the video could only corroborate that the occupant of the Gold Honda truck made contact with our caller in front of the store.

On 9/11/14, at approximately 1000 hours, I responded to the area of 305 Waymont Ct. within the City of Lake Mary, Florida in reference to a disturbance that just occurred. The complainant, Matthew Apperson called to inform Lake Mary Police of a suspicious vehicle (Honda Ridgeline) parked near one of the first buildings located on Waymont Ct. Matthew stated it matched the description of the vehicle which he recently had contact with two days prior. Matthew was unsure if the vehicle was following him regarding the previous incident.

I made contact with Matthew in front of his workplace, 305 Waymont Ct. Matthew advised there was no disturbance or confrontation today. Matthew stated that he was driving on W. Lake Mary Blvd. turning onto Waymont Ct. He stated that he immediately noticed a vehicle accelerate hearing the tires "chirp." leaving Waymont Ct. It was Sqt. Seda and PFC Komives made contact with the Honda Ridgeline bearing determined that the driver of the truck was George Zimmerman. I inquired if Matthew was requesting any specific law enforcement actions. Matthew stated he was not and simply wanted it brought to our attention reference to the suspicious vehicle, and possibly the same vehicle involved in this report. Matthew stated that he could not confidently identify the driver, but believed the vehicle
